I. Annotation

1. The name of the discipline in accordance with the curriculum is the application of the norms of international law in the Russian Federation (in English).

2. Goals and objectives of the discipline

The purpose of mastering the discipline is to form students' systematic ideas about the application of international law in the Russian Federation, the formation of knowledge, skills and abilities for effective professional activity using a foreign language - English.

The objectives of mastering the discipline are:

- study of regulatory and international acts;**
- acquisition of skills to analyze, interpret and apply the provisions of international and national legislation, as well as law enforcement practice;**
- training in drafting legal documents using the norms of international law;**
- development of professional language skills.**

3. The place of the discipline in the structure of the baccalaureate OOP

The discipline belongs to the number of elective disciplines.

The level of initial training of the student for the successful development of the discipline:

- have an idea of the content of the main branches of Russian and international law;**

The student's answer is evaluated according to the credit/non-credit system. As a result, to get a credit, you need to score at least 8 points.

VII. METHODOLOGICAL GUIDELINES FOR STUDENTS ON THE DEVELOPMENT OF THE DISCIPLINE

ОРГАНИЗАЦИЯ РЕЙТИНГ-КОНТРОЛЯ

1. Использование рейтинговой системы оценки качества учебной работы студентов ТвГУ определяется соответствующим локальным актом.

2. Каждый семестр делится на два модуля, которые завершаются контрольной точкой.

3. Формой рейтингового модульного контроля является тестирование.

4. Изучение дисциплины заканчивается зачетом.

На первый модуль отводится 40 баллов, которые распределяются следующим образом:

- текущий контроль – до 35 баллов;

- рубежный контроль – 5 баллов.

На второй модуль отводится 60 баллов, которые распределяются следующим образом:

- текущий контроль – до 55 баллов;

- рубежный контроль – 5 баллов.

5. На первом занятии преподаватель озвучивает обучающимся тематический и календарный график занятий, формы и сроки выполнения заданий, баллы, которые могут быть получены обучающимся за выполнение каждого из заданий.

Дополнительно обучающимся озвучиваются формы и правила выполнения заданий для получения премиальных баллов.

Topic 1. Practical aspects of interaction between Russian and international law.

The nature of relations between the national law of Russia and international law. "Rules-based order" and international law. Universal international law and regional integration. Divergence of legal regulation between the norms of national and international law. The legal quintessence of state sovereignty. The ultra vires principle.

Topic 2. Application by courts of general jurisdiction of generally recognized principles and norms of international law.

Resolution of the Plenum of the Supreme Court of the Russian Federation No. 5 dated 10.10.2003 "On the application by Courts of General Jurisdiction of generally Recognized principles and norms of International Law and international Treaties of the Russian Federation". The effect of international treaties concluded by the USSR. Direct application of international treaties of the Russian Federation. The procedure for the application of international treaties, the norms of which provide for signs of the composition of criminally punishable acts. The consequences of the incorrect application of the norms of international law. Difficulties in interpreting generally recognized principles and norms of international law, international treaties of the Russian Federation.

Topic 3. Application by courts of general jurisdiction of international treaties of the Russian Federation.

Application of self-executing contracts. Temporary execution of non-ratified contracts and the legal consequences of their application. Situations when the law enforcement

officer can apply the norm of an international treaty and when he must apply it in conjunction with the norm of national law. Resolution of the Plenum of the Supreme Court of the Russian Federation No. 21 dated 27.06.2013 "On the application by Courts of General Jurisdiction of the Convention on the Protection of Human Rights and Fundamental Freedoms of November 4, 1950 and its Protocols".

Topic 4. The effect of international treaties of the Russian Federation in the consideration of cases by arbitration courts.

Resolution of the Plenum of the Supreme Court of the Russian Federation dated 27.06.2017 No. 23 "On the consideration by arbitration courts of cases on economic disputes arising from relations complicated by a foreign element". The competence of the arbitration courts of the Russian Federation on economic disputes complicated by a foreign element. Confirmation of the existence of a close connection of the disputed legal relationship with the territory of the Russian Federation. Establishment of the legal status of a foreign person participating in the arbitration process. Requirements for documents of foreign origin. Establishment of the content of the norms of international and foreign law.

Topic 5. Issues arising in judicial practice in connection with the entry into force of the Customs Code of the Eurasian Economic Union.

Resolution of the Plenum of the Supreme Court of the Russian Federation dated 26.11.2019 No. 49 "On some issues arising in Judicial Practice in connection with the Entry into force of the Customs Code of the Eurasian Economic Union". Legal regulation of customs relations in the Russian Federation, taking into account the norms of international law. Conflicts between the norms of the law of the Union and the provisions of the legislation of the Russian Federation. The customs value of imported goods. Classification of goods for customs purposes. Features of consideration of cases involving foreign citizens.

Topic 6. Interrelation and interdependence of constitutional and international law.

Structural-functional and axiological aspects. Material and procedural influence. Constitutionalization of international law and internationalization of national law. Constitutional openness. Resolution of the Constitutional Court of the Russian Federation No. 21-P dated 14.07.2015 "On the Case of Checking the Constitutionality of the Provisions of Article 1 of the Federal Law "On Ratification of the Convention for the Protection of Human Rights and Fundamental Freedoms and Protocols Thereto", paragraphs 1 and 2 of Article 32 of the Federal Law "On International Treaties of the Russian Federation", Parts one and Four of Article 11, paragraph 4 of Part four of Article 392 of the Civil Procedure Code of the Russian Federation, parts 1 and 4 of Article 13, paragraph 4 of Part 3 of Article 311 of the Arbitration Procedure Code of the Russian Federation, parts 1 and 4 of Article 15, Paragraph 4 of part 1 of Article 350 of the Code of Administrative Procedure of the Russian Federation and paragraph 2 of part four of Article 413 of the Criminal Procedure Code of the Russian Federation in connection with the request of a group of deputies of the State

Duma." Principles that ensure the overcoming of inconsistency between the norms of international and constitutional law. The practice of the European Court of Human Rights and the Constitutional Law of Russia.

Topic 7. Application of the norms of international law in criminal cases.

"Review of the practice of application by courts of generally recognized principles and norms of international law and international treaties of the Russian Federation in the consideration of criminal cases" (approved by the Presidium of the Supreme Court 08.12.2021). Non-application of an international norm that is subject to application, or, on the contrary, the application by the court of a norm of international law that is not subject to application, or a misinterpretation of such a norm. The content of the norms of international law consistent with the legislation. Legal positions formulated by interstate bodies for the protection of human rights and freedoms, including the European Court of Human Rights, whose jurisdiction is recognized by the Russian Federation. Admissibility of evidence in a criminal case.

Topic 8. Interaction of international and civil law.

The ratio of private and public law in the Russian legal system. Interaction of public international and private international law. The problem of the "opposite" of the components of public and private in international law. Features of the application of the norms of international law in civil cases considered by the courts of the Russian Federation.

Topic 9. International labor standards.

Ways of interaction of international labor standards and national labor legislation. Compliance of the internal labor legislation of Russia with international labor agreements. The problem of authentic interpretation of international labor treaties. Features of the application of international advisory acts in the field of labor. International agreements in the field of labor, under which Russia does not have obligations.

Topic 10. International legal regulation and administrative law.

Development of international administrative law and international administrative bodies. The concept of a modern combination of transnational and national administrative and legal regulation. Application of international legal regulators of administrative relations. The doctrine of general (case-law) law in the regulation of administrative relations. Administrative and legal mechanisms of cooperation between states in the fight against corruption in the public service system.

3. Sample topics of abstracts and recommendations for their writing

1. Divergence of legal regulation between the norms of national and international law.
2. Direct application of international treaties of the Russian Federation.
3. Situations when the law enforcer can apply the norm of an international treaty and when he must apply it in conjunction with the norm of national law.
4. Establishment of the content of the norms of international and foreign law.

5. Legal regulation of customs relations in the Russian Federation, taking into account the norms of international law.
6. Constitutionalization of international law and internationalization of national law.
7. The content of the norms of international law consistent with the legislation.
8. Interaction of public international and private international law.
9. Ways of interaction of international labor standards and national labor legislation.
10. Application of international legal regulators of administrative relations.

Methodological recommendations: When writing an abstract, attention should be paid to the correspondence of the content to the topic of the abstract. In order to fulfill this requirement, it is recommended to draw up a plan of the abstract, discuss it with the teacher.

Mandatory structural elements of the abstract are the title page, the table of contents indicating the pages of sections, introduction, main part, conclusion, list of references. At the discretion of the author, a list of accepted abbreviations and appendices is included.

The volume of the abstract depends on the chosen topic, the degree of elaboration of the topic in the scientific literature, as well as on the author himself, but in any case it should be at least 15 pages. When making an abstract, the following field sizes are observed: left - not less than 20 mm, right - not less than 10 mm, upper and lower - not less than 20 mm. When typing text in electronic Word editors, it is necessary to use the Times New Roman font, font size 14, line spacing 1.5.

In case of difficulties in the design of quotations or literature, it is recommended to refer to the requirements of GOST.

The abstract is performed in English.

The abstract assumes a deep analysis of the theory and its connection with practice. Therefore, the abstract should reflect the main theoretical provisions of this topic with reference to information sources, analysis of these provisions, comparison of different points of view, formulation of conclusions. The author's conclusions should be reasoned.

When writing a paper, the author should rely on the most well-known works on the research topic, paying special attention to periodic publications. In order to get the highest scores, the originality of the text should be 70% or higher.

4. Typical tasks

1. In one of the international treaties of the Russian Federation, it was stated that the treaty contains indications of the obligations of the participating States to amend the domestic legislation of these States. Does this circumstance mean that this international treaty is self-executing? What legal actions should the Russian Federation take to fulfill this agreement in good faith?

When studying the discipline, it is necessary to be guided by international treaties, the Constitution of the Russian Federation, current federal laws and by-laws.

Successful study of this discipline is possible only with the proper organization of the student's independent work. It is recommended to use the system "Guarantor" and "Consultant plus" in preparation for the answer to get acquainted with international treaties, laws and regulations. In order to consolidate the acquired knowledge and check the level of training of the student on a specific topic of the discipline, it is necessary to answer the control questions formulated in the working program and, if necessary, return to additional study of specific issues of the topic.

The student should understand that only he himself, independently, through conscientious assimilation of the content of educational and additional literature, the meaning and content of the legal norms themselves and the practice of their application, through thoughtful and conscientious preparation for classes, can acquire solid and in-depth knowledge of the discipline, which is necessary not only for obtaining knowledge that meets the requirements of higher education, but also for their practical application.

The educational process involves the use of the following interactive teaching methods and information technologies: working in small groups, interactive presentation, drafting and analysis of legal documents, multimedia presentations, modeling of legal situations.
